Legal Structure Set-up:

If you've already decided on the legal structure you want, I can support you to set up a CIC or a charity.

The fee for setting up a CIC is £225+VAT (£270). This includes advice regarding the most appropriate form of CIC, support with completing the forms and online filing of your CIC application.

The fee for setting up a CIO (charity) is £900+VAT (£1080). This includes advice regarding your charitable objects and completion of the online application. It does not include preparation of any supporting documents required for the application (such as the business plan or any policies or procedures), which would need to be provided by you. If Charity Commission request additional information as part of the application process, up to one hour of my time is included in the above fee.
